This refers to the routine safety inspection conducted by Dr. Richard K. Struckmeyer, Ms. Rosemary T. Hogan, and Dr. Jason C. Jang of this office on April 23-27, 1984 of activities authorized by NRC at the Calvert Cliffs Nuclear Power Plant, Lusby, Maryland and to the discussions of our findings held by the inspectors with Mr. L. B. Russell at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspectors.

In addition, our Mobile Laboratory was also brought to your site and used by the inspectors to make certain independent measurements. The basic purpose of these independent measurements is to verify your capability for analyzing radioactive effluents, and to achieve and maintain comparable methods of analyses between your facility and the NRC. The complete data from these measurements will be reported in a subsequent Inspection Report.

Our inspectors also verified the steps you have taken to correct the violations brought to your attention in the enclosure to our letter dated May 20, 1983. We have no further questions regarding your action at this time.


Based on the results of this inspection, it appears that one of your activities was not conducted in full compliance with NRC requirements, as set forth in the Notice of Violation, enclosed herewith as Appendix A. This violation has been categorized by severity level in accordance with the revised NRC Enforcement Policy (10 CFR 2, Appendix C) published in the Federal Register Notice (49 FR 8583) dated March 8, 1984. You are required to respond to this letter and in preparing your response, you should follow the instructions in Appendix A.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure will be placed in the NRC Public Document Room unless you notify this office, by telephone, within ten days of the date of this letter and submit written application to withhold information contained therein within thirty days of the date of this letter. Such application must be consistent with the requirements
