This letter refers to our virtual Skype meeting on March 31, 2020, during which we discussed the Nuclear Regulatory Commission's (NRC's) evaluation of your performance in the four major areas of safety operations, radiological controls, facility support, and safeguards (details not discussed with the public) during calendar year 2019. The meeting was beneficial and provided the NRC the opportunity to discuss your facility's performance during the last assessment period. The meeting also afforded you the opportunity to provide feedback to the NRC regarding your perception of the NRC performance review.

The meeting also afforded the members of the public the opportunity to ask questions and provide feedback to the NRC regarding our inspection program for the Columbia Fuel Fabrication Facility (CFFF).
