Subject: NRC Region I Inspection Report 50-333/84-09

This refers to the routine safety inspection in the transportation area conducted by Ms. R. T. Hogan of this office on May 21-25, 1984 of activities authorized by NRC License No. DPR-59 and to the discussions of our findings held by Ms. Hogan with Mr. McNeill and other members of your staff at the conclusion of the inspection.

Areas examined during this inspection included management controls, package selection, waste classification, training and audits and are described in the attached NRC Region I Inspection Report 50-333/84-09.

Our inspector also verified the steps you have taken to correct the violation brought to your attention in a letter dated April 13, 1983. We have no further questions regarding your action at this time.

Based on the results of this inspection, it appears that certain of your activities were not conducted in full compliance with NRC requirements, as set forth in the Notice of Violation, enclosed herewith as Appendix A. This violation has been categorized by severity level in accordance with the revised NRC Enforcement Policy (10 CFR 2, Appendix C) published in the Federal Register Notice (49 FR 8583) dated March 8, 1984. You are required to respond to this letter and in preparing your response, you should follow the instructions in Appendix A.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure will be placed in the NRC Public Document Room unless you notify this office, by telephone, within ten days of the date of this letter and submit written application to withhold information contained therein within thirty days of the date of this letter. Such application must be consistent with the requirements of 2.790(b)(1). The telephone notification of your intent to request withholding, or any request for an extension of the 10-day period which you believe necessary, should be made to the Supervisor, Files, Mail and Records, USNRC Region I, at (215) 337-5223.
