Dear Mr. Gipson:

Thank you for your 10 CFR 50.54(a) submittal dated May 5, 1995, which incorporates changes in your Quality Assurance Program description (QAPD). We have reviewed the changes associated with this submittal. In addition, we have reviewed the changes in Chapter 3.2 of your Updated Safety Analysis Report regarding the QA Program Scope, and the changes in Appendix A describing your regulatory guide commitments. Our review determined that changes to Revision 6 of your QAPD in the area of audit program frequencies, previously approved by letter dated August 2, 1994, had been deleted from your May 5, 1995, submittal. This issue was discussed between Mr. F. Maura of this office and Ms. L. Goodman of your staff during June 1995. By letter dated September 29, 1995, you resubmitted the previously approved audit program as Revision 7a. We have completed our review and based on the information provided in your September 29, 1995 letter, we conclude that these revisions continue to meet the requirements of 10 CFR Part 50, Appendix B, and are acceptable. In the future, if you intend to make the effective date of a change to your QAPD contingent on some other action or event, please state so in your request. We consider any requested change to the QAPD to be effective at least no later than the date of our approval letter.

If there are changes to QA commitments existing in docketed correspondence outside of the Quality Assurance Program description, you are obligated to notify this office.

We appreciate your timely submittal of information required by 10 CFR 50.54(a). Please contact me at (708) 829-9751 with any questions you may have regarding this matter.
