During a teleconference on March 18, 1992, you informed us that you would need approval of the CENTS code by March 1993 so that you can revise your technical specification references for Core Operating Limits Report (COLR) methodologies to permit use of the code in the Cycle 15 Reload. Please tell us what the effect would be, and your course of action, if the code were not approved until June 1993 or not approved before the end of your next refueling outage in November 1993.
