This refers to the routine inspection conducted by an NRC team on June 25-28, 1984 of activities authorized by NRC License No. DPR-66 and to the discussions of our findings held by R. H. Smith with you and other members of your staff at the conclusion of the inspection.

The area examined during this inspection was limited to the annual emergency full scale exercise. Within this area, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the team members.

Within the scope of this inspection, no violations were observed.
