This letter refers to the routine security inspection conducted by Messrs. G. Smith and R. Albert of this office on March 16-19, 1992, of activities authorized by NRC License Nos. DPR-66 and NPF-73 and to the discussions of our findings held by Mr. Smith with Mr. D. Spoerry and other members of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspectors. Additionally, the inspectors examined the Fitness-for-Duty (FFD) issues remaining open after our initial inspection of the FFD program conducted on October 16-18, 1990.

We found that the physical security program being implemented at the Beaver Valley Power Station was directed toward the protection of public health and safety and noted that the continuing program upgrades were contributing to the overall effectiveness of the program. No violations were identified.
