This refers to the inspection conducted under the Resident Inspection Program by Mr. G. L. Plumlee III of this office during the period June 1-30, 1984, of activities authorized by NRC Operating License DPR-34 for Fort St. Vrain Nuclear Generating Station, and to the discussion of our findings with Mr. D. W. Warembourg, and/or other members of your staff at the conclusion of the inspection.

Areas examined during the inspection included Operational Safety Verification, Maintenance, TMI Action Plan Requirement Followup, Independent Inspection, Licensee/NRR Meeting, and Review of Periodic and Special Reports. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspector. These findings are documented in the enclosed inspection report.

During this inspection, it was found that certain of your activities were in violation of NRC requirements. Consequently, you are required to respond to Violation 8415-02, in writing, in accordance with the provisions of Section 2.201 of the NRC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations. Your response should be based on the specifics contained in the Notice of Violation enclosed with this letter. The NRC inspector has reviewed corrective actions in regard to Violation 8415-08 during this inspection period, therefore, you are not required to respond to this violation.

During this inspection, it was found that certain of your activities appeared to deviate from accepted commitments made to the NRC. This item and reference to the commitment is identified in the enclosed Notice of Deviation. You are requested to respond to this deviation in writing. Your response should be based on the specifics contained in the Notice of Deviation enclosed with this letter.
