This refers to the inspection conducted by Mr. James A. F. Kelly of this office during the period June 26-29, 1984, of activities authorized by NRC Construction Permit CPPR-147, for Wolf Creek Generating Station, and to the discussion of our findings with Mr. F. T. Rhodes and other members of your staff at the conclusion of the inspection.

Areas examined during the inspection included the security plan and implementing procedures. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspector. These findings are documented in the enclosed inspection report.

Within the scope of the inspection, no violations or deviations were identified.
