Reviews for Nine Mile Point, Units 1 and 2

2. Nine Mile Point, Unit 2, Quality Assurance Program
dated June 11, 1984

We have reviewed the changes to the Quality Assurance Programs identified in References 1 and 2 above and found these changes to be acceptable.

Additionally, the staff noted the following concerns in the unrevised portions of these programs:

1. Section 2.9 was added to Unit 1 Quality Assurance (QA) Program to discuss the fire protection program. However, such a revision was not made to the Unit 2 QA Program. In light of the fact that Unit 2 is now nearing completion of construction and entering preoperational phase, the NRC staff discussed the need for incorporating a fire protection program description into Section D.2.2 of the Unit 2 QA program with Messrs. J. Perry and D. Palmer of your organization on August 7, 1984. Messrs. Perry and Palmer agreed to incorporate a fire protection program description in Section D.2.2 of the Unit 2 QA Program.
2. Except for the Quality Assurance organizations, the requirements and responsibilities for training personnel performing activities affecting quality were not discussed in either QA program. This matter was also discussed with Messrs. Perry and Palmer on August 7, 1984. Messrs. Perry and Palmer agreed to incorporate the training requirements and responsibilities into the Program Sections (Section II for Unit 1 and Section D.2.2 for Unit 2) of both units.
