SUBJECT: REQUEST FOR MEETING ON DETAILED CONTROL ROOM
DESIGN REVIEW (DCRDR) PROGRAM PLAN -
JOSEPH M. FARLEY NUCLEAR PLANT UNITS 1 AND 2

By letter dated March 9, 1984, we provided our comments on the DCRDR Program Plan for Joseph M. Farley Nuclear Plant, Units 1 and 2. We indicated in our comments that you should submit the referenced INPO Nuclear Utility Task Action Committee (NUTAC) document on the docket if these documents will be used to support your DCRDR activities.

By letter dated April 3, 1984, you submitted the reference INPO NUTAC documents for the NRC staff review. You stated in that letter that an NRC review is essential prior to a meeting on the DCRDR Program Plan which is based upon the NUTAC documents. No mention is made in the April 3rd letter that NRC conduct a review of your DCRDR Program Plan based upon the NUTAC documents. Furthermore, our review of all licensee's DCRDRs is based upon the requirements of Supplement 1 to NUREG-0737 and the guidance contained in NUREG-0700 and draft NUREG-0801.

By letter dated April 26, 1984, you requested an NRC review based on the NUTAC documents which were docketed on April 3, 1984. You also advised us of your concurrent detailed comparison of your DCRDR Program Plan to the NUTAC documents. However, you did not state your schedule completion date for your comparison and explanation of any deviations that exist.

On this basis, we request a meeting with your staff to discuss the Farley Nuclear Plant DCRDR Program Plan as it relates to the NUTAC documents. In preparing for this meeting you should review all applicable draft comments on the NUTAC documents provided to Mr. H. C. Fish, Jr., Chairman DCRDR, NUTAC, by letter from our Mr. V. A. Moore dated April 11, 1984.
