This routine inspection of the Susquehanna Steam Electric Station covered NRC open items, Unit 2 startup testing, a review of two Unit 1 scrams, and Technical Specification surveillances. The inspection focused upon missed surveillances that were caused by individual work group problems. Your staff identified and reported two cases of missed surveillances, and the inspector identified a third. Although the causes were not common, more attention is needed in this aspect of the surveillance program.

This inspection identified two violations of NRC requirements. Two chemistry surveillances, required to be performed on a once-per-eight hour basis by a Technical Specification Action statement, were not performed within the required frequency. Also, inadequate control of surveillance activities allowed for fire detaction instrumentation surveillances for twelve fire zones not to be performed within the required frequency. Please reply to these matters in accordance with the enclosed Appendix A. That reply is not subject to clearance by the Office of Management and Budget under the Paperwork Reduction Action of 1980, PL 96-511.

This transmittal will be made public unless you notify this office, within 10 days of the date of this letter, that you intend to request withholding of information under 10 CFR 2.790(b)(1).
