Subject: Inspection Report Nos. 50-272/84-24, 50-311/84-24

This refers to a special unannounced inspection conducted by R.J. Everett of our Region IV office on May 29, 1984. A shipment of radioactive waste shipped from your facility at Hancock's Bridge, New Jersey was involved in a transportation accident near Rock Springs, Wyoming.

Areas examined during the inspection and our findings are discussed in the enclosed inspection report. Within these areas, the inspection consisted of a review of the shipping papers, placarding and labeling requirements, radiation measurements, selective contamination surveys, and examination of the packages, and the tractor trailer.

Within the scope of this inspection, no violations were observed.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure will be placed in the NRC Public Document Room unless you notify this office, by telephone, within ten days of the date of this letter and submit written application to withhold information contained therein within thirty days of the date of this letter. Such application must be consistent with the requirements of 10 CFR 2.790(b)(1). The telephone notification of your intent to request withholding, or any request for an extension of the 10-day period which you believe necessary, should be made to the Supervisor, Files, Mail and Records, USNRC Region I, at (215) 337-5223.

No reply to this letter is required. Your cooperation with us in this matter is appreciated.
