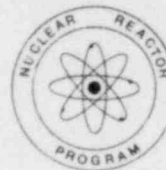

Dear Mr. Thomas:

In accordance with our previous correspondence dated June 14, 1984, to your office concerning a proposed implementation delay of the PULSTAR Emergency Plan, Docket No. 50-297, Revision 1 of the specified plan has been completed. Specifically, our Radiation Protection Council approved the Revision 1 of the PULSTAR Emergency Plan on July 18, 1984, with only minor modifications (reference the attached correspondence to my office from the Radiation Protection Council).

However, as specified in your correspondence to my office dated July 12, 1984, we are unable to meet the August 15, 1984, deadline for submission of Revision 2 of the PULSTAR Emergency Plan. This delay in submission of the revised plan results from the inability of the offsite agreement agencies to complete their review of the revised plan in the specified time interval and provide our facility with a new Letter of Agreement.

Revision 1 of the PULSTAR Emergency Plan was hand delivered on July 26, 1984, to the six offsite organizations/agencies that support the PULSTAR Emergency Plan. To date we have received correspondence from four of these organizations indicating their support of the revised plan. Letters of Agreement from these four organizations are attached. The remaining two offsite agencies, namely, the State Radiation Protection Section and the State Emergency Management Agency, have advised our facility of their scheduling difficulties in reviewing the revised plan. Correspondence from both of these agencies is attached that details their delay in completing review of the Revision 1 of the PULSTAR Emergency Plan.

As soon as the specified reviews are completed and Letters of Agreement provided, we will submit Revision 1 of the PULSTAR Emergency Plan to the Commission. Based on the correspondence provided by the remaining two offsite agencies, it is expected that the submission will occur in late September.

As a matter of information, I have included a draft copy of Revision 1 of the PULSTAR Emergency Plan. Note that until full agreement is reached with the





The Radiation Protection Council has reviewed Revision 1 of the PULSTAR Emergency Plan as transmitted by your letter of 25 June 1984. Based on this review, including the work session which was held with you on July 18, 1984, the Radiation Protection Council approves this revised plan for submission to the Nuclear Regulatory Commission. This approval is, of course, granted with the understanding that those modifications to Section 7.0 which were agreed to during our July 18, 1984 meeting will be incorporated into the plan. As you will recall, these modifications have to do with insuring that an emergency response scenario is devised for the situation where a large, essentially instantaneous, loss of primary coolant could take place.





This will acknowledge receipt on July 26, 1984 of your Draft Emergency Response Plan for the Pulstar Reactor; in conjunction with your request for a signed agreement with the Radiation Protection Section.

As noted to you during our meeting on July 26, 1984, there are a number of critical priorities in my program which will preclude our technical review of your draft emergency plan until mid- to late-September. Accordingly, we will be unable to meet your requested action deadline of August 15, 1984.

Based upon our current situation, it appears that we should be able to complete our review and, assuming that there are no major problems with references to my program, sign the necessary agreement on or before the end of September 1984. In this regard I should note that I do not personally anticipate an ultimate problem with our signing the necessary agreement. 
