SUBJECT: REVIEW OF REVISION 12 TO THE PERRY PLANT'S EMERGENCY PLAN

Dear Mr. Shelton:

In April 1995, Region III received Revision 12 to the Perry Plant's Emergency Plan. We have reviewed this revision and determined that it is acceptable and does not decrease the effectiveness of your emergency planning.

Revision 12 included refinements to some criteria for classifying emergency events. Several refinements were made to the emergency response organization. Acceptable simplifications or clarifications were provided on the following: the means for accomplishing emergency response training; groups responsible for assessing drill and exercise performance; means of accomplishing periodic emergency communications equipment tests; and criteria for maintaining letters of agreement with offsite support agencies. Revision 12 included a number of updated letters of agreement, other information updates, clarifications and editorial changes.
