Rated Thermal Power Level Increase to 2568 MWt.

Reference: FPC to NRC letter, 3F0994-08, dated September 30, 1994

Dear Sir:

The reference letter submitted a request to allow Crystal River Unit 3 (CR-3) to operate with a maximum rated thermal power of 2568 MWt. Through an oversight, Florida Power Corporation (FPC) did not include in the submittal a request to modify the wording in CR-3's Operating License Condition 2.C.(1) to reflect the increased power level. This submittal corrects the docket submittal.

Upon NRC approval of the increased thermal power, Operating License No. DPR-72 License Condition 2.C.(1), <u>Maximum Power Level</u>, should read as follows:

Florida Power Corporation is authorized to operate the facility at a steady state reactor core power level not in excess of 2568 Megawatts (100 percent or rated core power level).
