Subject: Modification No. 10 to Task Order No. 13 entitled, "Individual Plant Examination (IPE) Reviews - Internal Events - Front End Only (Pilgrim) under Contract No. NRC-04-91-066

The purpose of this modification is to (1) correct "Modification No. 6" dated 2/28/95 to read "Modification No. 7"; "Modification No. 7 dated 4/5/95 to read "Modification No. 8"; and "Modification No. 8" dated 7/6/95 to read "Modification No. 9"; and (2) extend the period of performance of the subject task order from December 31, 1995 through March 31, 1996, at no additional cost or obligation to the Government. The extension is needed to allow NRC to perform its internal reviews and provide comments to the contractor. Accordingly, the task order is hereby modified to read as follows:

The first sentence of Paragraph 2 of the definitization letter is deleted in its entirety and the following is substituted in lieu thereof:

"Task Order No. 13 shall be in effect from April 16, 1993 through March 31, 1996, with a total cost ceiling of \$34,879.80."
