Subject: Modification No. 3 to Task Order No. 31 entitled, "Individual Plant

Examination (IPE) Reviews - Internal Events - Human Factors Only

(Nine Mile Pt. 1) under Contract No. NRC-04-91-069

The purpose of this modification is to (1) extend the period of performance of the subject task order from December 31, 1995 through March 31, 1996, at no additional cost or obligation to the Government. The extension is needed to allow NRC to perform its internal reviews and provide comments to the contractor, and (2) correct the reimbursable cost amount of Modification No. 2 to Task Order No. 31 under the subject contract. The fixed fee and total cost ceiling amounts remain unchanged. Accordingly, the task order is hereby modified to read as follows:

The first sentence of Paragraph 2 of the definitization letter is deleted in its entirety and the following is substituted in lieu thereof:

"Task Order No. 31 shall be in effect from May 18, 1994 through March 31, 1996, with a total cost ceiling of \$19.323.87."

The third sentence of Paragraph 2 of Modification No. 2 to Task Order No. 31 is deleted in its entirety and the following is substituted in lieu thereof:

"ha revised ceiling as a result of this modification is \$19.323.87 of which the total estimated reimbursable costs is \$18.059.72 and the amount of \$1.264.15 represents the fixed fee."

A summary of obligations for this task order, from award date through the date of this action is given below:

This modification obligates FY96 funds in the amount of \$-0-.
