(Enforcement Conference)

This refers to the Enforcement Conference held on July 18, 1984, at the Indian Point Nuclear Generating Station, Buchanan, New York, to discuss the findings of Special Inspection No. 50-247/84-13. The topics discussed at this meeting included the June 19, 1984, unplanned exposure of two workers and the adequacy of the Radiological Controls Program at the Indian Point Nuclear Generating Station, Unit 2.
