Enclosed is the NRC report of the October 17-19, 1995, announced inspection of the James A. FitzPatrick Nuclear Power Plant emergency preparedness (EP) full-participation, biennial exercise led by Mr. D. Silk. Our inspection findings are based on inspector observations, discussions with your staff, and document review. At the end of the inspection, the preliminary NRC findings were discussed with you and other members of your staff.

Overall, the on-site response to the exercise scenario was very good. The assignment of licensed operators as communicators at the emergency response facilities and the good interface with off-site officials at the emergency operations facility were assessed as exercise strengths. No exercise weaknesses were identified. No safety concerns or violations of NRC regulatory requirements were identified.
