
To Whom It May Concern:

Pursuant to the Freedom of Information Act (FOIA), 5 U.S.C. \$552, the Government Accountability Project (GAP) of the Institute for fully Studies requests copies of any and all agency records and information, including but not limited to notes, letters, memoranda, drafts, minutes, diaries, logs, calendars, tapes, transcripts, summaries, interview reports, procedures, instructions, engineering analyses, drawings, files, graphs, charts, maps, photographs, agreements, handwritten notes, studies, data sheets, notebooks, books, telephone messages, computations, voice recordings, and other data compilations, interim and/or final reports, status reports, and any and all other records relating to consideration of the TERA Corporation's independent design and construction verfication program (IDCV) as one of the pilot programs under the provisions of Section 13 of Public Law 97-415 (NRS Authorization Act for FY83).

Specifically, we request all notes, documents, telephone logs, etc. relating to meetings between the NRC, TERA, and Consumers on May 18, 1983, June 8, 1983 and June 22, 1983.

If any records have been destroyed and/or removed, please provide all surrounding records, including but not limited to a list of all records which have been or are destroyed and/or removed, a description of the action(s) taken, relevant date(s), individual, office and/or agency-wide policies and/or justification(s) for the action(s), identification of all personnel involved with the action(s), and any and all records relevant to, gen\_rated in connection with, ard/or issued in order to implement the action(s).

GAP requests that fees be waived, because "finding the information can be considered as primarily benefitting the general public." 5 U.S.C. 3552(a)(4)(A). SUBJECT: MANPOWER ESTIMATE FOR TERA MEETING PARTICIPATION

In followup to our discussion regarding NRC participation in all meetings between TERA and Consumers Power Company and/or its consultants for the IDCV program on the Midland Plant, I called H. Levine on 6/17/83 to determine the frequency of such meetings. The meetings are held monthly and are scheduled about one week after issuance of the monthly status report. Occassionally, additional meetings may be scheduled to discuss special findings; however, these should be infrequent and reasonable efforts will be made to combine these with the monthly meeting. The meetings are held either at Lynchburg, Midland or Ann Arbor, depending upon the principal items to be discussed.

One meeting has been held to date. This was on June 3, 1983, in Ann Arbor and discussed the Confirmed Items from the May 27, 1983, Status Report. The meeting was not noticed because of TERA's interpretation at the April 13, 1983, meeting that the Protocol for Communications which NRC provided 3/28/83 applies only at the findings stage. The NRC has yet to respond to TERA's interpretation.

I propose the following. I should prepare a letter to TERA advising them that NRC believes that meetings with CPCo and its consultants on substantive matters applies to discussions on Confirmed Items, and that all such future meetings should be subject to the Protocol. The letter should also request that TERA, rather than CPCo, assume responsibility for noticing and meeting summaries. The June 3, 1983, meeting should also be summarized by TERA and distributed to the IDCV service list. RIII and NRR should attend all future meetings. Mr. R. Warnick agrees with this proposal and has also asked me to advise TERA in the letter that the NRC no longer believes that the ICV program needs to await rework resulting from the Construction Completion Program.

I have also proposed to Mr. J. Stone that an audit to gain familarization with TERA's records maintenance facilities and practices be conducted in the near future. Mr. P. Kesheshian will be conducting audits periodically as part of the Ford Amendment addition.

On April 22, 1983, Mr. G. Gower and I visited Mr. R. Snyder at the TERA Corporation offices in Bethesda, Maryland. The purpose of the visit was to observe, for familiarization purposes, the filing system for controlled documents associated with the independent design and construction verification (IDCV) program for the Midland Plant, Units 1 & 2.

The documents reviewed and their file identif'er are identified in TERA's Project Quality Assurance Plan 3201, Section 4. Records were observed to be maintained in a central location, and were categorized by subject for easy retrieval. Drawings are maintained in a separate Drawing Room utilizing stick files. The listing of drawings maintained by TERA includes the current revision number of each drawing.

TERA's meeting minutes for the June 3, 1983, meeting in Ann Arbor, MI which discussed the Confirmed Items in the first monthly progress report (issued May 27, 1983), were reviewed. I noted that NRC views regarding the protocol for such meetings will be the subject of separate correspondence in the near future.



FORD AMENDMENT PILOT PROGRAM

Section 13 of Public Law 97-415 (NRC Authorization Act for FY 83) requires NRC to conduct a study of existing and alternative approaches to quality assurance and to report the results to Congress in April, 1984. Section 13 of the act, referred to as the Ford Amendment, also requires that NRC evaluate five specific alternatives, one of which involves a pilot program to be conducted at three or more reactors under construction. Independent third party audits of the QA program and its implementation is one concept which must be tested in the pilot program. At present, the management of the Marble Hill and Palo Verde projects have agreed to participate as pilots for the third party audit concept. Discussions are continuing with the management of the Midland and South Texas projects. These discussions are being handled by James Taylor, Director, Division of Quality Assurance, Safeguards, and Inspection Programs.

The Ford Amendment requires also that NRC evaluate the effectiveness of audits, evaluations, or appraisals by associations of professionals. In order to meet this requirement, a member of my staff, Paul Keshishian, will be accompanying INPO as an observer on their Construction Evaluation of Beaver Valley 2 on May 16-27, 1983. Mr. Keshishian will also be monitoring and evaluating the effectiveness of the third party audits being conducted at the other sites (Torrey Pines' review of Palo Verde is complete; he will be reviewing it after the fact as well as corrective actions taken in response to the audit).

Enclosed for your information is a copy of Public Law 97-415, a March 3, 1983 Federal Register Notice, and two quarterly reports to the Commission on the status of the QA initiatives. Paul Keshishian or Willard Altman will be

Subject: Implementation of Ford Amendment Pilot Program on Midland Plant, Units 1 and 2

Section 13 of Public Law 97-415 (NRC Authorization Act for FY 83) requires the NRC to conduct a study of existing and alternative approaches to quality assurance and to report the results to Congress in April, 1984. Section 13 of the act, referred to as the Ford Amendment, also requires that NRC evaluate specific alternatives, one of which involves a pilot program to be conducted at a few reactors under construction. Independent third party audits of the QA program and its implementation is one concept to be tested in the pilot program. In order to meet this requirement. the NRC will be monitoring and evaluating the effectiveness of the third party audits being conducted at selected sites.

This is to confirm your commitment to Mr. J. Taylor of NºC's Office of Inspection and Enforcement to utilize the Independent Design and Construction Verification (IDCV) program which is being performed by the TERA Corporation on Midland Plant, Units 1 and 2 as one of the pilot programs. Based on this agreement, the NRC has initiated discussions with TERA to modify the program as necessary to incorporate this commitment.
