SUBJECT: NRC INSPECTION REPORT 50-445/95-98: 50-446/95-98

This refers to the inspection conducted by Mr. C. J. Paulk and Ms. L. J. Smith of this office on August 4, 1995, via telephone with personnel from the Comanche Peak Steam Electric Station. Units 1 and 2, facility. Information gained during NRC Inspection 50-445/95-13: 50-446/95-13 was also used in preparing this report. This initiative was prompted by recurring failures of safety-related steam turbine-driven standby pumps at several facilities in Region IV. We concurrently performed this inspection at each of the Region IV facilities to better understand the scope of design. maintenance, and testing practices related to safety-related steam turbines. which were supplied by the Terry Corporation. We also examined several aspects of various experience review processes to determine why similar failures continued to occur. On November 9, 1995, at the conclusion of the in-office review, the findings were discussed with those members of your staff identified in the enclosed report.

Areas examined during the inspection are identified in the report. Within these areas, the inspection consisted of selective examinations of procedures, representative records, and interviews with personnel. The combined results of this inspection for each of the Region IV facilities are documented in the enclosed report and executive summary.

With respect to your facility, the inspection found that your staff had plans to address most of the failure mechanisms described in this report. For example, at the exit interview your staff stated that they planned to establish a periodic preventive maintenance program for the auxiliary feedwater turbine governor valve. They had also planned to redesign the turbine steam line condensate removal system to delete the steam traps and provide a passive drain system. The NRC's evaluation of the complete corrective action plan for the June 1995 auxiliary feedwater pump turbine failures will be documented in NRC Inspection Report 50-445/95-25; 50-446/95-25.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice." a copy of this letter and its enclosures will be placed in the NRC Public Document Room.
