SUBJECT: NRC INSPECTION REPORT 50-285/95-15

This refers to the inspection conducted by Mr. Arthur D. McQueen and other members of this office on November 13-16, 1995, at the Fort Calhoun Station facility. The purpose of the inspection was to determine whether activities authorized by the license were conducted safely and in accordance with NRC requirements. At the conclusion of the inspection, the findings were discussed with you and those members of your staff identified in the enclosed report.

Areas examined during the inspection included the implementation of your emergency plan and procedures during your emergency preparedness exercise. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observation of activities in progress. The results of this inspection are documented in the enclosed report.

Two exercise weaknesses identified during the inspection are discussed in Sections 3 and 4 of the enclosed inspection report. The weaknesses involved a failure to have an individual properly trained and capable of performing core uncover predictions, and the simulation of exercise activities by in-plant response teams in a manner which precluded evaluating individuals' knowledge of duties.


Exercise weaknesses, according to 10 CFR Part 50, Appendix E.IV.F.2.g, are inspection findings that need to be corrected by the licensee. You are requested to provide this office with a description of your corrective measures and your schedule for completing these actions within 30 days after receipt of this letter.
