This refers to the routine safety inspection conducted by Ms. M. Miller of this office on July 2-3 and 5-6, 1984 of activities authorized by NRC License No. CPPR-106 and to the discussions of our findings held by Ms. Miller with Mr. G. Leitch of your staff at the conclusion of the inspection.

Areas examined during this inspection of the Chemistry and Radiation Protection Programs are described in the NRC Region I Inspection Report which is enclosed with this letter. Areas examined with regard to your provisions for fuel transfer and inspection activities are described in NRC Region I Inspection Report 50-352/84-30, which has been previously transmitted.

Within the scope of this inspection, no violations were observed.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure will be placed in the NRC Public Document Room unless you notify this office, by telephone, within ten days of the date of this letter and submit written application to withhold information contained therein within thirty days of the date of this letter.
