This refers to the routine safety inspection conducted by Lewis Narrow of this office on June 11-15, 1984 at the Pilgrim Nuclear Power Station, Plymouth, Massachusetts of activities authorized by NRC License No DPR-35 and to the discussions of our findings held by Mr. Narrow with Mr. P.E. Mastrangelo and other members of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of this inspection, no violations were observed.
