This letter is in response to your correspondence of March 2, 1992, regarding changes to the James A. FitzPatrick Nuclear Power Plant Physical Security Plan identified as Revision 14.

We have reviewed the changes submitted and have determined that they are consistent with the provisions of 10 CFR 50.54(p) and acceptable for accusion in the Plan.

In the course of reviewing your Plan for items which might conflict with your commitment to Regulatory Guide 5.66, it was noted that the record retention period specified in Chapter 11 is not in consonance with either section 73.56 or 73.10. This should be corrected in your next Plan revision.

The enclosure to your letter contained Safeguards Information of a type specified in 10 CFR 73.21 and is being withheld from public disclosure.
