Subject: Inspection Nos. 50-317/84-08 and 50-318/84-08

This transmits the April 11 - May 15, 1984 resident inspection findings by Messrs. T. Foley and D. Trimble at the Calvert Cliffs Nuclear Power Plant, Lusby, Maryland. Those findings were based on observation of activities, interviews, independent measurements, and document reviews, and have been discussed with Mr. Russell of your staff.

This inspection identified significant safety concerns regarding the operability of the Component Cooling Heat Exchangers. A meeting was held on May 17, 1984 which proved to be beneficial in our understanding of your approach to the technical and managerial aspects of this event.

Based on this meeting we consider this issue to be resolved pending follow up of your stated actions by the resident inspectors. Our understanding of your actions has been documented in my letter to you dated July 2, 1984.

In accordance with 10CFR2.790(a), a copy of this letter and the enclosures will be placed in the NRC Public Document Room unless you notify this office, by telephone, within 10 days of the date of this letter and submit written application to withhold information contained therein within 25 days of the date of this letter. Such application must comply with 2.790(b)(1).
