SUBJECT: COMBINED INSPECTION REPORT NOS. 50-352/92-10 AND 50-353/92-09

This letter transmits the results of the routine resident safety inspection by Messrs. T. Kenny and L. Scholl, from February 16, - March 14, 1992, at the Limerick Generating Station, Limerick, Pennsylvania. The inspection consisted of document reviews, interviews, and observations of activities. The results have been discussed with Mr. Graham Leitch and Mr. J. Doering of your staff.

The inspection found that the Unit 1 shutdown for its fourth refueling outage was well controlled. Operator attention to detail and use of procedures were very good. We also noted that you checked electrical inverters for problems following an intermittent problem with the high pressure coolant injection system inverter. This was a good safety initiative. Further, we found your preparation and assessment for the resulting temporary waiver of compliance to be thorough. No violations were identified by the NRC during this inspection.

We appreciate your cooperation.
