## SUBJECT: EMERGENCY RESPONSE DATA SYSTEM IMPLEMENTATION PLAN

The U.S. Nuclear Regulatory Commission (NRC) has reviewed the Emergency Response Data System (ERDS) implementation plan which was submitted by Omaha Public Power District in a letter dated October 28, 1991. Based upon this review, the NRC has found that your implementation plan provides the basis for an acceptable implementation of the computer aspects of ERDS at your facility. Although the technical aspects of ERDS implementation were well covered in your implementation plan, the administrative aspects of the ERDS program were not discussed. These administrative requirements are outlined in Section 3.6 of NUREG-1394 (Rev. 1), as well as in 10 TFR Part 50, Appendix E, Section VI.3. Completion of these steps will be required for certification of compliance with the change to 10 CFR Part 50 concerning ERDS.

Be advised that the testing phase of ERDS implementation involves all licensees testing with the NRC contractor, Halliburton NUS Environmental Corporation. Since the contractor does not have unlimited resources for testing multiple ERDS links simultaneously, close coordination with the Halliburton NUS personnel in scheduling your ERDS testing will be a key element in the successful completion of ERDS implementation.
