SUMMARY OF SALP MEETING WITH THE LICENSEE ON JUNE 21, 1984 AT THE D.C. COOK VISITORS CENTER, BRIDGMAN, MICHIGAN

The findings and conclusions of the SALP Board documented in Report Nos. 50-315/84-08 and 50-316/84-09 were discussed with the licensee on June 21, 1984, at the D. C. Cook Visitors Center in Bridgman, Michigan. The licensee's regulatory performance was presented in each functional area. Overall performance and performance in each functional area was found to be acceptable. The performance rating in three functional areas; Maintenance and Modifications, Fire Protection, and Refueling, improved over the previous assessment period. All other functional areas remained the same. Included in the latter category is Quality Programs and Administrative Controls which, although displaying an improving trend, has not appreciably improved over the last two SALP periods.

While this meeting was primarily a discussion between the licensee and NRC, it was open to members of the public as observers.
