Subject: Systematic Assessment of Licensee Performance

This letter refers to the annual NRC SALP for the Shoreham Nuclear Power Station, including the June 6, 1984 discussion of the SALP findings with you at the plant site and your June 26, 1984 response letter to the May 4, 1984 SALP report.

Our overall assessment is that your performance was acceptable during this period of construction completion and readiness for operation. We have observed substantial improvements in LILCo's performance and responsiveness to NRC concerns during the past year, and we attribute these improvements to increased senior management attention and involvement in activities at the plant. Continued management attention will be needed to resolve the diesel generator problems at the plant, and we expect you to continue your efforts to improve the BWR operating experience among plant management and licensed personnel.

After reviewing your response letter, we have concluded that it is not necessary to modify or supplement our SALP report. Accordingly, a copy of this letter and its enclosure will be placed in the NRC Public Document Room.

No reply to this letter is required. Your cooperation with us is appreciated.
