This letter confirms verbal authorization provided to your office by Brenda DuBose, of my staff, to commence work under the subject task order effective March 29, 1992, with an established ceiling of \$10,000.00.

In accordance with the task order procedures of the subject contract, this letter definitizes Task Order No. 61. This effort shall be performed in accordance with the enclosed Statement of Work, the Contractor's proposal dated March 23, 1992, and the following telephonic changes of March 27, 1992:

- 1.) Reduce fixed fee by \$210.76 from \$1,633.12 (7.75%) to \$1,422.76 (6.75%).


