MOTION FOR RECONSIDERATION

I. INTRODUCTION

On August 15, 1984 the Licensing Board issued an "Order Establishing Schedule For Offsite Emergency Planning Issues" in the captioned matter. On page two thereof, the Licensing Board directs that the participating parties shall receive --- "by expedited means, the report on the Limerick exercise by the FEMA regional office, estimated to be issued on or about September 1, 1984." The NRC Staff (Staff) hereby moves the Licensing Board to reconsider that part of its Order.

II. DISCUSSION

On August 20, 1984 FEMA advised the Staff that the September 1, 1984 report on the Limerick exercise by its regional office was considered by FEMA to be a draft report and did not constitute the final agency position of the exercise. The agency position on the exercise must await FEMA head-quarters review of the exercise results. For this reason, draft regional reports have traditionally not been made available to the public or to

parties in ongoing licensing procedures. FEMA further advised that the final agency report on the exercise is due on or about October 1, 1984, and will be made available to the Licensing Board the parties and the public. $\frac{1}{2}$

CONCLUSION

In view of the foregoing, Staff moves the Licensing Board to reconsider that portion of its Order of August 15, 1984 so that FEMA will not be required to distribute a draft report from its regional office to the Licensing Board and the parties.
