SUBJECT: EXAMINATION REPORT, Fort Calhoun Station (FCS)

On June 5-7, 1984, NRC administered examinations to employees of your company who had applied for licenses to operate your FCS facility. At the conclusion of the examinations, the examination questions and preliminary findings were discussed with those members of your staff identified in the enclosed report. Your attention is directed to sections 3.B. and 3.C. (pages 5-7) of the enclosed report which detail examination performance information which has become a cause for concern to NRC with regard to the adequacy of the FCS operator training program. Please provide a written response within 60 days of receipt of this report describing your corrective actions taken or planned regarding the weaknesses identified in your training program..

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosed report will be placed in the NRC Public Document Room unless you notify this office, by telephone, within 10 days of the date of this letter, and submit written application to withhold information contained therein within 30 days of the date of this letter. Such application must be consistent with the requirements of 2.790(b)(1).
