Dear Mr. Campbell:

This refers to the inspection conducted on November 13-17, 1995, at the Brunswick facility. The purpose of the inspection was to determine whether activities authorized by the license were conducted safely and in accordance with NRC requirements. At the conclusion of the inspection, the findings were discussed with those members of your staff identified in the report.

Areas examined during the inspection are identified in the report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observation of activities in progress.

The enclosed Inspection Report identifies activities that violated NRC requirements that will not be subject to enforcement action because the licensee's efforts in identifying and/or correcting the violations meet the criteria specified in Section VII.B. of the Enforcement Policy. Although non cited, we remain concerned about the violations because: 1) the failure of licensee personnel to follow proper decontamination procedures upon exiting the RCA could lead to the inadvertent spread of contamination and; 2) the failure to post a radiation area properly could lead to unnecessary personnel exposures. Thus, we will review the effectiveness of your corrective actions for these non cited violations and continue to monitor closely future performance in these areas.

In accordance with 10 CFR 2.790, of the NRC's "Rules of Practice," a copy of this letter will be placed in the NRC Public Document Room.
