Subject: Combined Inspection Nos. 50-277/92-10 and 50-278/92-10

This refers to the safety inspection conducted by Mr. J. J. Kottan of this office on April 6-10, 1992 of activities authorized by NRC License Nos. DPR-44 and DRP-56 at the Peach Bottom Atomic Power Station, Units 2 and 3 and to the discussions of our findings held by Mr. Kottan with Mr. D. LeQuia and others of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

In addition, chemistry standards prepared by Oak Ridge National Laboratory (ORNL) for the NRC were submitted to your site laboratory for analysis. The basic purpose of these analyses is to verify your capability to measure chemical parameters in various plant systems, and to achieve and maintain comparable methods of analysis between your facility and ORNL.
