Dear Mr. Shelton:

Thank you for your 10 CFR 50.54(a) submittal dated August 31, 1995, which incorporate changes in your Quality Assurance Program description. We have reviewed the changes associated with this submittal. Questions resulting from this review were discussed between Mr. F. Maura of this office and Mr. K. Peck of your staff on October 24, 1995. As a result of this discussion, you revised your submittal by letter dated December 14, 1995. In addition, we understand that as part of your next USAR update, Regulatory Guides 1.8, Revision I-R, and 1.26, Revision 3, will be included in Table 1.8-2, "Compliance with QA-Related NRC Regulatory Guides." This is required in order for the Perry Plant USAR to be in agreement with the Safety Evaluation Report (NUREG 0887) dated May 1982 and SER Supplement No. 7, dated November 1985. Based on the revision provided by your December 14, 1995 letter, and our understanding regarding the next update of your USAR, we conclude that these revisions continue to meet the requirements of 10 CFR Part 50, Appendix B, and are acceptable.

If there are changes to QA commitments existing in docketed correspondence outside of the Quality Assurance Program description, you are obligated to notify this office.
