SUBJECT: FEMA OFFSITE EXERCISE REPORT FOR EDWIN T. HATCH NUCLEAR POWER STATION

Please find enclosed a copy of the Federal Emergency Management Agency's (FEMA) Report for the offsite portion of the Hatch Nuclear Power Station Exercise of October 2, 1991.

As described in the enclosure, there were no deficiencies identified during this exercise. However, two Areas Requiring Corrective Actions (ARCAs) were identified and several items were recommended for improvement.

These ARCAs involved the failure to calibrate Field Monitoring Team air sampling equipment annually and communications with Georgia Department of Natural Resources boats.

We encourage you to assist the appropriate organizations in resolving the corrective actions and improvement items identified by FEMA. Resolution of these items should be completed prior to the next full-scale emergency preparedness exercise.

We also encourage you to work closely with the State and counties in the development of a scenario for the next full-scale exercise that will effectively test the areas in which the above items were disclosed.

Your cooperation in this matter is appreciated.
