- State the number of devices you are planning to use and whether they are to be permanently bench mounted or portable.
- Your application states that you will have ring badges. Please explain if all
  your employees who are using the device will be instructed to wear the ring
  badge while operating the lixiscope.
- 3. In order to be named as an authorized user, a person must have attended an NRC approved course. We will not be able to approve of anyone other than Carol Stoltman to appear on the license as an authorized user as she is the only person to have attended an approved course.
- 4. If you wish to establish an "in-house" training program, you must submit a course outline and verification that Ms. Stoltman's training allows her to train other users. A letter from Gilbert Zweig stating that Ms. Stoltman is qualified to train other users would be satisfactory.

The NRC is writing the authorized user condition for lixiscopes to read "by, under the supervision of, and in the physical presence of that the authorized user must be physically present when the device is being used. The authorized user could not be on another floor or out of the building when the device is being used. Your intention of having shift supervisors be named authorized users would satisfy this condition, after they have completed the NRC approved training course.

5. State the name(s) of the personnel who will be doing the source exchange.
