This acknowledges the receipt of your letter of April 3, 1992, which transmitted Revision 1 to the Turkey Point Physical Security Plan.

Our review of the changes has found most of them to be consistent with the provisions of 10 CFR 50.54(p). Accordingly, they are acceptable for inclusion into the plan.

Several changes do not meet the intent of 10 C.R 50.54(p) in that they appear to decrease the effectiveness of the physical security plan. These are described in the enclosure to this letter. Please revert to your original security plan commitments in these areas. One change requires clarification. In order for us to review Section 12.1 dealing with Access Authorization under the provisions of 10 CFR 50.54(p) this section must state that all elements of Regulatory Guide 5.66 have been implemented. Also commitments spelled out in the plan dealing with access authorization must agree with this Regulatory Guide. You may submit the above changes to NRC's Headquarter's Office of Nuclear Reactor Regulation for review. Section 5.61 and Appendix B have been referred to NRC's Headquarter's Office of Nuclear Reactor Regulation for review since they deal with vital areas. You will be advised of the decision on this matter by separate letter. These issues were discussed in a teleconference on April 21, 1992, between Ms. O. Masnyk of the Region staff and Mr. F. Timmons of Florida Power and Light Company.

The enclosure to your letter is being withheld from public disclosure because it contains Safeguards Information and must be protected in accordance with the provisions of 10 CFR Part 73.21.

The material enclosed herewith contains Safeguards Information as defined by 10 CFR 73.21 and its disclosure to unauthorized individuals is prohibited by Section 147 of the Atomic Energy Act of 1954, as amended. Therefore, the enclosure will not be placed in the Public Document Room.
