Areas examined during the inspection included the effectiveness of the engineering and technical support organization at the Calvert Cliffs Unit 1 and 2 nuclear engineering offices and plant site. Within these areas, the inspectors selectively examined engineering organization procedures and effectiveness in implementation of modifications and facility changes. Organizational changes separating plant engineering activities from those of longer range engineering concern provided for a clearer focusing of engineering responsibilities. Modifications reviewed displayed a high level of technical review, resulting in improved design alternatives toward a more reliable and safe operating plant. Procedure development enabled engineering to more effectively implement the design modifications.

Performance indicators developed allowed engineering management to identify weak areas and provide for appropriate corrective action. Engineering initiatives currently under way indicate corporate management's support of engineering programs that provide for continued safe and reliable operation, consistent with the Code of Federal Regulations, Technical Specifications and Final Safety Analysis Report.
