This confirms verbal authorization provided to you on November 1, 1995 to commence work under Modification No. 5 to Task Order No. 32.

In accordance with Section G.5. <u>Task Order Procedures</u>, of the subject contract, this letter definitizes Modification No. 5 to Task Order No. 32 which: (1) correct "Modification No. 3" dated 6/26/95 to read "Modification No. 4", (2) increases the level of effort by adding 24 professional hours for continued performance of work under Task Order No. 32 due to a change in contractor personnel to complete support efforts for the NRC in the review of the Vermont Yankee IPE submittal, and (3) increases the task order's ceiling by \$3,030.00 from \$27,892.00 to \$30,922.00. The obligated amount of this modification is \$3,030.00. Accordingly, the task order is hereby modified as follows:

The third and fourth paragraphs of the definitization letter of the basic task order are deleted in their entirety and the following is substituted in lieu thereof:

"Task Order No. 32 shall be in effect from May 16, 1994 through December 31, 1995, with a total cost ceiling of \$30,922.00. The amount of \$28,633.00 represents the total estimated reimbursable costs and the amount of \$2,289.00 represents the fixed fee."

"The amount presently obligated by the Government with respect to this task order is \$3,030.00."
