Subject: Modification No. 5 to Task Order No. 41 entitled, "Individual Plant Examination (IPE) Reviews for Back End Containment Performance and Source Term Analysis - Internal Events Only (Salem Units 1 and 2) under Contract No. NRC-04-91-068

The purpose of this modification is to extend the period of performance of the subject task order from December 24, 1995 through December 31, 1996, at no additional cost or obligation to the Government. The extension is needed to allow NRC to perform its internal reviews and provide comments to the contractor. Accordingly, the task order is hereby modified to read as follows:

The first sentence of Paragraph 2 of the definitization letter is deleted in its entirety and the following is substituted in lieu thereof:
