Docketing and Service:

On May 1, 1992, the Licensing Board in the above-captioned proceeding issued a Memorandum and Order (Conditionally Granting APCo Motion to Continue Proprietary Treatment of Certain Exhibits). This Memorandum and Order concerns certain exhibits in this proceeding that are currently being treated as proprietary.

As noted in the Memorandum and order, Alabama Power Company (APCo) has previously supplied the Docketing and Service Branch with three copies of each of three APCo exhibits with proprietary pages deleted.^{1/} The Licensing Board ordered that, in addition,
