SUBJECT: NRC INSPECTION REPORT NOS. 50-269/92-09, 50-270/92-09 AND 50-287/92-09

This refers to the inspection conducted by P. E. Harmon during the period March 1-28, 1992. The inspection included a review of activities authorized for your Oconee facility. At the conclusion of the inspection, the findings were discussed with those members of your staff identified in the enclosed inspection report.

Areas examined during the inspection are identified in the report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observation of activities in progress.

The enclosed inspection report identifies activities that violate NRC requirements that will not be subject to enforcement action because the licensee's efforts in identifying and/or correcting the violations meet the criteria specified in Section VII.B of the Enforcement Policy.

The enclosed inspection report also identifies that the level of activity in the control room during low power physics testing concurrent with reactor coolant pump testing for maintenance appeared to be excessive. This indicates, in this specific example, that all command and control problems have not been solved.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice", a copy of this letter and its enclosure will be placed in the NRC Public Document Room.
