SUBJECT: NRC INSPECTION REPORT NOS. 50-321/92-04 AND 50-366/92-04

This refers to the Motor-Operated Valve inspection conducted by U. S. NRC, Region II at your Plant Hatch facility from February 24-28, 1992 and March 31, 1992. The inspection consisted of a review of the program you developed in response to Generic Letter (GL) 89-10, "Safety-Related Motor-Operated Valve Testing and Surveillance". Areas examined during the inspection are discussed in the enclosed inspection report.

At the conclusion of the inspection, the findings were discussed with those members of your staff identified in the report. It was determined that you had developed a program which adequately addressed most of the GL recommendations. However, some concerns were identified. These are listed in the Summary Section of the enclosed inspection report. No response is requested for these concerns. In your response, dated December 28, 1989 to GL 89-10, Motor-Operated Valve Program Description you stated that exceptions were taken to the GL recommendations with regard to (1) in situ testing and (2) the completion schedule and scope for in situ dynamic testing. However, the inspection revealed that these two areas are being performed in accordance with the GL recommendations. We are therefore requesting a written response to clarify your commitments to GL 89-10. Please inform us within 60 days of receipt of this letter of your planned actions to address this concern.

In addition to the concern described above, the inspection identified a number of strengths as well as several concerns which do not require a response at this time. These concerns and strengths are listed in the inspection report Summary. All of the concerns are discussed in Section 3 of the inspection report.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter and its enclosure will be placed in the NRC Public Document Room.
