SUBJECT: SEQUOYAH UNPLANNED SHUTDOWN IN EXCESS OF 72 HOURS

At 8:23 p.m., on April 28, 1992 Sequoyah Unit 1 experienced a reactor trip. The cause of the trip has been identified as the failure of a relay in the 'B' transformer protective circuitry. The relay failure caused an actuation of the generator output breakers. The reactor tripped as a result of a turbine generator trip with the reactor power at greater than 50%. The relay has been replaced.

While in hot shutdown recovering from the trip, at 10:26 p.m., on April 29, the unit had a safety injection/reactor protection system actuation. An inadvertent opening of all the steam dump valves caused the rate adjusted steam line low pressure actuation of the SI and a vessel injection. A Notification of Unusual Event was declared. The NOUE was exited at 3:30 a.m., April 30, 1992. A controller failure is suspected. The controller is being been replaced.

Unit 1 is expected to restart May 2, 1992. Unit 2 was in a shutdown condition for a scheduled refueling outage during both events.

The licensee made a press release.

The State of Tennessee was informed by the licensee.
