Dear Mr. Lazarony:

The purpose of this letter is to inform you of the individual examination results for your applicants on the initial examination conducted on November 20, 1995 - and November 28, 1995 - December 1, 1995, at your facility. This meets the intent of section E.1 of the Examiner Standards (ES 501) in NUREG 1021. This information is considered to be "proprietary" in accordance with 10 CFR 2.790 and it supplements the information contained in the related examination report for your facility which will be issued shortly.
