SUBJECT: WITHDRAWAL OF LICENSE AMENDMENT REQUEST-SAFETY-RELATED SNUBBER TABLE CHANGES, JOSEPH M. FARLEY NUCLEAR PLANT UNIT 2

By letter dated December 8, 1983, you proposed changes to the Unit 2 Technical Specification Table 3.7-4a, "Safety Related Hydraulic Snubbers." The changes involved twenty-six pages of Table 3.7-4a. Our review of your application has been completed and concludes that the changes you proposed are acceptable.

However, by Generic Letter 84-13 dated May 3, 1984, "Technical Specifications for Snubbers" we advised licensees that such tabular listings of snubbers may be removed from Technical Specifications as an administrative licensing action. On the basis of our Generic Letter 84-13, your letter dated July 6, 1984, proposes deletion of the snubber tables from the Farley Technical Specifications to Table 3.7-4a. You also withdrew the proposed changes for Unit 2.

We consider your action appropriate. By this action you eliminate the need for our issuing the license amendment. However, since our review was essentially completed before receipt of your July 6, 1984, letter, the administrative class II fee will not be refunded. By this letter we accept your amendment withdrawal request. No further action will be taken on the December 8, 1983 request.

By letter dated December 8, 1983, you proposed changes to the Unit 2 Technical Specification Table 3.7-4a, "Safety Related Hydraulic Snubbers." The changes involved twenty-six pages of Table 3.7-4a. Our review of your application has been completed and concludes that the changes you proposed are acceptable.

However, by Generic Letter 84-13 dated May 3, 1984, "Technical Specifications for Snubbers" we advised licenses that such tabular listings of snubbers may be removed from Technical Specifications as an administrative licensing action. On the basis of our Generic Letter 84-13, your letter dated July 6, 1984, proposes delation of the snubber tables from the Farley Technical Specifications. In the same letter, item 4) of attachment 1, you withdrew the proposed changes dated December 8, 1983, for Unit 2.

We consider your action appropriate, by this action you eliminate the need for our issuing the license amendment which would then be voided by action on your July 6, 1984 request. Since our review was essentially completed before your July 6, 1984, letter, the administrative class II fee will not be refunded. By this letter we accept your amendment withdrawal request. No further action will be taken on the December 8, 1983 request.
