Fire protection sprinkler system 2A-25 was removed from service for surveillance testing at 0809 on 8-1-84. A continuous fire watch was posted in accordance with Technical Specification 3.7.11.2. However, at 1830 on 8-1-84 it was determined that the fire watch had not been maintained as required although maintenance personnel had been in the area intermittently (working on 2A-25). A continuous fire watch was posted immediately and maintained until no longer required. Investigation revealed that the fire watch had been maintained until approximately 1130 when it was mistakenly discontinued.

This event was due to personnel error. The Shift Foreman did not provide adequate fire watch instructions and did not ensure that the fire watch requirements were met. The individual has been counseled. The fire watch system has been reviewed and a system to provide more positive control over fire watches is being implemented. This incident will be discussed with operations group supervision responsible for establishing fire watches.
